Applications may be declined if details submitted are inaccurate or incomplete.</p> <p>c. Memberships include coverage for the applicant only. Membership privileges do not extend to family members. Photo identification will be required when visiting Cincinnati Dental Care to verify the identity of a person possessing a Cincinnati Dental Care Membership program</p> <p>d. Cincinnati Dental Care has the right to cancel memberships before the duration stipulated if unauthorized users are utilizing the membership. A refund will not be given.</p> <p>e. You must be at least 18 years old to submit an application for membership with Cincinnati Dental Care Parents can submit an application on the behalf of a child up to the age of 18.</p> <p>f. It cannot be used as a secondary membership to any primary insurance plan.
